Waiver and Release of Liability

I/we understand that I/we must be present and responsible for supervising my/our child/children at all Trinity Chapel, His Master's Voice School of Music (HMV) recreational and educational activities that my children participate in unless I/we have authorized an alternative His Master's Voice School of Music member parent to act on my behalf and to be responsible for supervising my child/children and this exception is only allowed if students are able to drive themselves to classes. No driving student is to leave Church property until their classes are completed or in cases of emergency. His Master's Voice School of Music is not responsible to supervise any child/children. I/we understand that preschool and nursery aged children are never allowed on Church property without a parent/guardian/member to supervise.

I/we understand that His Master's Voice School of Music does not provide insurance relative to accidents or injuries because of program related activities. I/we understand that I/we are responsible for the health/medical care of my child/children in the event of an injury or accident during any His Master's Voice School of Music activity/classes.

I/we understand that His Master's Voice School of Music has a no tolerance policy for student misconduct. Students that continue to violate the conduct policies of His Master's Voice School of Music may be dismissed from their class/classes at the administration's discretion. Expulsion from class does not negate responsibility to pay the annual tuition for said class.

I/we have read this Waiver and Release of Liability form and I/we understand the contents of this form. I/we understand that the participation of the child/children named in His Master's Voice School of Music is voluntary and that the child/children and I/we are free to choose not to participate in these activities and program. I/we understand that if I/we withdraw, we are obligated to fulfill our financial obligation to His Master's Voice School of Music. If any damage to property belonging to His Master's Voice School of Music or Trinity Chapel is done by the child/children listed, we are obligated to fulfill the financial obligation of replacement of said damage.

By signing this, I/we waive, discharge and covenant not to sue His Master's Voice School of Music or Trinity Chapel, their agents, officers, attorneys, employees, associates, affiliates, successors and assigns and all other persons, firms or corporation, whether or not specifically named, herein, jointly, severally, of and from any and every claim, demand, right or cause of action, of whatever kind of nature, whether in tort, contract, or created by statute, directly or indirectly, for any injuries, damages, or losses the undersigned may incur as a result of his or her participation and involvement in His Master's Voice School of Music.
